IV. Report from Student Body President Jack Batz

Student Senate has been focused on the changes to the commencement ceremony. Student feedback did lead to a compromise – changing from the administration's original plan of three undergraduate ceremonies down to two ceremonies. Student senate passed a resolution asking for continued discussion moving forward regarding future commencements. Election season is coming up.

V. Reports from Administrators

A. Provost and Senior Vice President for Academic Affairs Zakahi

- 1. VPs have held listening sessions with faculty who work with international students. The goal is to enhance their experiences with low- or no-cost changes. Most of our graduate students are from India, and they believe that word-of-mouth recruiting is important with this prospective recruiting pool so good experiences are important.
- 2. Rui Li has shared a draft of an intellectual property policy document with the Deans and received feedback that is being incorporated. Expect that within 2 weeks or so college leadership will see revised draft.
- 3. Noted the loss of our colleague Lori Russell-Chapin and what a huge loss for the University this is.

Questions

Sen. Landon Williams – Said there have been rumors in the last few weeks regarding applications to the MBA program – students are hearing that it is going online or being canceled altogether. Asked for clarification on what is happening.

Prov. Zakahi – A decision has not been made, we are holding on the decision based on enrollment. We are considering the possibility of replacing the current MBA program with a couple of "niche" masters programs in high demand areas that would be online programs – there is a hold on student applications until the decisions are made. Hoping to make a decision by the end of the year.

LW – If the program is cancelled will it be communicated to students? Will it go through University Senate?

WZ – Yes, to the communication, not sure to whether it would go through University Senate.

Sen. Smith – Will my application for tenure be decided on its merits? Zakahi – "I would imagine" that we would evaluate based on merits TS – Asked if he could get that in writing.

WZ - Said he would have to consult others before answering

Edward Flint – Asked how many positions have been lost based on the Fall 2023 cuts and how many positions will be hired for fall and how many more will be lost in the next year. WZ – Did not have the numbers available

Pres. Drake – Asked if the Provost could bring these data to the next meeting WZ – agreed to this

Sen. Teresa Drake – Asked if the IP policy would come through C&R and through senate. WZ – Indicated that he has no objection to routing through senate, but was uncertain whether the committee should be C&R or Contractual Arrangements.

B. President Standifird

- 1. Update to bonding structure Noted that the suggestion in the recent WCBU article that violation of covenant led to the recent cuts was misleading. Commented on bond restructuring that is being worked on now. CFO will provide more details in April.
- 2. Commented on the success of the men's basketball team and how important community support is and how important the exposure is.

- 3. We are getting \$950,000 in federal appropriations to purchase equipment and train 23 engineers per year to develop electrification standards for reliable solar power production. Credited both Senator Dick Durbin and David Zietlow for making this happen.
- 4. Noted that a core element of our strategic vision is the ability to understand and respond to the needs and desires of students. To aid with this Sen. Muncie is heading up a "student voice project" that involves open-ended student interviews, the results of which will be used to create focus group conversations in fall. Setting up structure to do this on a biannual basis.
- 5. Commented on anti-semitic graffiti on campus and reiterated that we will not tolerate actions of this sort. Indicated that there is an active investigation underway and that we plan to implement activities that promote civil dialogue on campus in anticipation of tense issues related to upcoming elections.

Questions

Eden Blair – Noted that administration didn't use student needs in their decision making process related to the recent cuts.

- SS Stated that student demand (enrollment) is part of student voice.
- EB Reminded the President that he stated in a Senate meeting that they only looked at financial information. She asked if he thinks that's all students care about. Also noted that 61 faculty have been cut and asked how that equals \$10 million dollars in savings.
- SS Offered to come back and talk about it at a later meeting. But stated that the savings from these cuts actually comes out to \$10.4 million dollars. He noted that he has a very complicated spreadsheet that shows this and that this spreadsheet has been shared with the Board of Trustees.
- EB Asked whether the budget will be \$10M less next year?
- SS Said "No" and that it will be phased in over time and we will expand faculty in some areas where there is desperate need
- EB Asked what the permanent change in budget will be moving forward? Noted the understanding that the Board demanded \$10M in permanent cuts.
- SS Stated that any new or replacement faculty lines will be based on student demand and that he is unable to say exactly what that number is going to look like 4 years from now.

Adalia Yeung (student) – Noted that there aren't many sections of courses available in the schedule of classes, and many of them are 100-level, and asked what the university is going to do about this, including how they plan to handle waitlists.

SS – Said that we will address it by finding people to teach the needed sections if this occurs.

Sen. Tyler Smith – Reminded the president that at the February meeting he had asked about cuts to administration, and that the President said he would have the details on that by the end of March.

SS – Stated that 70 staff reductions have occurred and that he is working on restructuring the senior leadership team. He said he had hoped to be able to share today – but that given the high profile nature of those positions he doesn't want to share unless there is

absolute certainty. He stated he is confident that he will be able to share in April and that he is committed to executing the changes by the end of semester.

Pres Drake – Noted that based on the Miles education contract it looks like student tuition will be \$14,000 by the time we pay Miles and asked if this is accurate.

SS – Said he was unable to answer and would need to consult with WZ or EK

Motion to approve – Sen Schweigert

Andy Kindler – explained the purpose of the edits.

- 1. Remove "grades posted" entries they belong in other locations.
- 2. Add semester info to final exam entries to make clear these are only for traditional semester courses.
- 3. Add "term ends" wording, not just commencement.
- 4. Make May interim a standalone like January interim. So now five blocks, fall, Jan, spring, may, summer

Sen. Timm – Noted that faculty cuts mean that we need to reduce the number of committees and their size. Suggested passing the motion now but revisiting later. Unanimous approval

D. Contractual Arrangements

Report on the Miles Education agreement – posted on Canvas.

Elena Gabor - Committee is concerned about

- 1. \$5000 per student fee seems high were their attempts to negotiate it down?
- 2. How will students be properly trained in business law if our Business Law program is being discontinued?
- 3. Is there a strategy around "boutique" tuition prices?
- 4. Contract stipulates mediation rather than the more commonly used arbitration
- 5. Staff will be ready but staff positions are precarious and do not make a living wage.

Sen Timm – Asked whether the committee posed these questions to administration EG – Noted that they shared it with Pres. Drake, who can forward to administration Sen. Smith – Indicated that the contract was signed Feb. 29, before the committee evaluated it.

Sen. Corbett – Asked how \$19,000 compares to other graduate programs we have.

Pres. Drake – Noted that as a point of reference, the average tuition for undergrads (with discounts) is \$17,000

Sen. Corbett – Suggested this seems like a too low tuition rate and asked whether senate had the \$19,000 number?

Eden Blair – Noted that her department had agreed to helping deliver this program contingent on getting another faculty line.

Sen. Hogan – Asked what the handbook says about senate or senate committee role in approving these sorts of contracts before they are signed? Should we strengthen the language?

EG – Agreed and noted this was the first time a contract of this nature came to the committee

Sen. Karin Smith — Asked how many credit hours are in the program as this would help allow pricing comparison to nursing grad programs. Answer was 21 hours, and Sen Smith then noted this makes the pricing comparable to nursing.
